



## **GSSI and certification schemes complete pilot test, getting Global Benchmark Tool ready to go live**

*EMBARGOED UNTIL 9 SEPTEMBER 2015*

The Global Sustainable Seafood Initiative (GSSI) completed its pilot test of the Global Benchmark Tool for seafood certification schemes. The pilot, which ran from March to July, helped GSSI's Independent Experts assess the Tool in real life situations getting it ready to go live on 8 October 2015 at the 20<sup>th</sup> anniversary celebrations of the FAO Code of Conduct for Responsible Fisheries in Vigo, Spain.

Eight seafood certification schemes from across 7 countries worldwide participated in the pilot, which was co-funded by IDH (The Sustainable Trade Initiative). Thanks to strong collaboration, GSSI's Tool has been further updated using lessons learned, now available in a [report on the GSSI Website](#).

Through its Global Benchmark Tool for seafood certification schemes GSSI is working towards building confidence in certified seafood. As part of the road-test, certification schemes worked closely with GSSI's Experts at offices in Iceland, Indonesia, the Netherlands, Thailand, Vietnam, the UK and USA. The pilot looked in detail at the benchmark process to test the Tool's ability to benchmark certification schemes, which is going to support improvement in the seafood sector.

*"The pilot was GSSI's moment of truth as it had to pressure test the GSSI Global Benchmark Tool against its open stakeholder developed procedures and criteria. Dr. Pham Anh Tuan, Deputy Director General, Department of Fisheries, Vietnam (VietGAP) states: *“Sustainability is an important issue for the seafood industry in Vietnam. However, the many international standards operating in Vietnam today tend to cause confusion and duplication. Therefore, the Vietnamese government developed the Vietnam National standard on Good Aquaculture Practice (VietGAP) and certification system, based on the FAO Technical Guidelines for Aquaculture Certification and the CCRF. VietGAP supports the GSSI mission to build confidence in certified seafood through the GSSI Global Benchmark Tool, and participation in the GSSI Pilot Test has helped to further build understanding on the essential components for credible certification.”*
